

PREFACE

The Ninth Plan (2002-2007) begins amidst unprecedented historical changes in Bhutan. Under the enlightened and compassionate leadership of His Majesty the King, we have witnessed unparalleled political and administrative reforms that have established a strong foundation for the development of a dynamic system of governance that upholds the true principles of democracy. The decentralization process, initiated by His Majesty the King in 1981, was fostered over two decades by gradual increases in authority and responsibility commensurate with the people's ability. This steady process of decentralization culminated in 1998 with the devolution of executive powers from the Throne to the elected Council of Ministers.

In November 2001, in yet another historic move, His Majesty commanded the drafting of a written constitution for the country. As the pillar of the country's governance, the constitution will embody the expectations and aspirations of the people to safeguard the sovereignty and security of the *Palden Drukpa*, and the rights of the Bhutanese people, for all time to come.

The *Chathrims* for the *Dzongkhag Yargye Tshogchung* and the *Gewog Yargye Tshogchung* are being revised to provide additional authority for the formulation, execution, monitoring and implementation of development activities.

The Ninth Plan itself also reflects these changes. Significantly, the Ninth Plan will be made up of 201 Gewog plans that have been formulated by the communities and their elected representatives. In addition, they will be responsible for its implementation, monitoring and evaluation, with only technical backstopping support being provided by the Dzongkhag and central agencies.

The Ninth Plan is the result of several intensive consultations in which all stakeholders, individuals at the community level, to the central ministries, have participated. It reflects our macro-economic situation, our priorities, the themes and objectives of our development, and the strategies to achieve them.

The total size of the Ninth Plan is Nu. 70,000 million, made up in almost equal parts of capital and current outlay. This is an increase of almost 75 percent over the Eighth Plan expenditures. Since the guiding philosophy of our national development, "Gross National Happiness", is to maintain a balance between material progress and spiritual well-being, the Ninth Plan accords high priority to both infrastructure development, improvement in the quality of social services and preservation and promotion of our culture and environment. In addition, an added emphasis is being made on the development of the private sector as their growth is essential for sustaining further progress.

As in the past, the needs of Bhutan are still far greater than its resources. Much has been achieved but much more still remains to be done. On our part, the Royal Government remains committed to the full coverage of recurrent expenditure by domestic resources but at this stage of our development, we will still require support for most of our investment programs. In this respect, we look forward to that same spirit of support and cooperation from our development partners, which has made possible all our development successes so far.

I take this opportunity to express my appreciation to all the sectors and agencies for their timely inputs and to thank them for their cooperation. I would also like to acknowledge the valuable support and guidance received from the members of the Planning Commission in producing this document.

The Eighth Plan is now nearing completion and I am pleased to report that we have successfully implemented almost all of the development programs and activities. I would like to share this success with our development partners, and thank them for their support. I would also like to take this opportunity to assure our people and development partners that with the same level of optimism, determination and cooperation, the Ninth Plan will be even more successful in taking Bhutan closer to the fulfillment of its vision.

May the blessings of the guardian deities of Palden Drukpa and the hard work and enlightened leadership of our Beloved King continue to bring peace and prosperity to the people of Bhutan.

INTRODUCTION

The Ninth Plan Main Document provides the macro-economic framework, key national as well as sector policy guidelines and general direction for the Ninth Plan. The document is divided into five parts:

- Part I provides background information on the country and its development philosophy of “Gross National Happiness”;
- Part II is a review of the country’s economic performance during the Eighth Plan and explains about development planning and management in the country;
- Part III deals with the different development themes such as poverty, employment, women, children and gender, private sector, governance, preservation and promotion of culture and environment, which underscore the Ninth Plan priorities and focus;
- Part IV spells out the Ninth Plan objectives, strategies and the Plan outlay. It provides the macro-economic framework and briefly highlights the Dzongkhag and Gewog plans in terms of their focus and outlay in the Ninth Plan; and
- Part V contains 15 sector specific chapters. Each chapter includes information on the current situation of the sector and highlights the objectives and strategies which will govern the sector’s development activities during the Ninth Plan.
